**4. Links Provided:** The contents of the Website may include links to third party materials ("linked sites"). TREESCAPE LTD will not be responsible for the

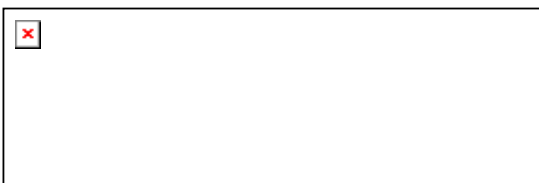
